Highlights:

Eligibility for Membership

Should be a life member of IMA TNSB. Can join in both the schemes: FSS 1 & FSS 2.

Age Limit

Upper age to join both in FSS-I & FSS-II for new members is 55 years. Upper age to join both in FSS-I & FSS-II for reentrants is 55 years with the following preconditions:

- 1. Allowed to join for a limited period of time till 30th June 2023.
- 2.Should pay admission fees of Rs.5000/- apart from the Outstanding backlog fraternity contributions from the date of deletion and they are exempted to pay NRD.
- 3. New membership enrollment number will be issued for the reentrants.

Greetings from IMAFSS.

Family Security Scheme of IMA TNSB hereby notify that the 29th AFC for the year 2023 is Rs.18,000/-(Rupees Eighteen Thousand Only) @Rs.200×90 Deaths (1016 to 1105). All members from FSS-No: 01 to 11534 are requested to pay the 29th AFC before 31st March 2023 without Late fee.

From 1st April to 30th June the late fee will be Rs.200, 1st July to 30th September the Late fee will be Rs.400, 1st October to 31st December the Late fee will be Rs.600.

On the death of a member, if one AFC due is pending it will be deducted and if one AFC due is pending after three months 10 times of the advance amount will be deducted

If not paid 29th AFC before 31st December he/she will be declared as a defaulter and the Membership of FSS will be terminated after a registered notice"
